## STANDARD CODE OF RULES

This document contains the Standard Code of Rules developed by The Football Association for open age football (the “Standard Code”).

The Standard Code is mandatory for all Competitions at Regional NLS Feeder League level and below, and Tier 7 and below of The FA Women’s Pyramid.

Competitions seeking sanction must draft their Rules in conformity with the Standard Code, using the same numbering and standard headings.

The mandatory rules are printed in normal text and the *optional rules in italics*.

It should be noted that in many cases rules are so printed because they are alternatives and the procedure to apply should be retained and the others omitted.

In all cases where a [ ] is shown the necessary name, address, number or wording to complete that rule must be inserted.

Competitions may add to the core of the Standard Code, which is mandatory, providing the additions are approved by the Sanctioning Authority and do not conflict with the mandatory rules or any relevant principles and policies established by The FA.

### 1. DEFINITIONS

1.A	<p>In these Rules:</p> <p>“Affiliated Association” means an Association accorded the status of an Affiliated Association under the rules of The FA.</p> <p>“AGM” shall mean the annual general meeting held in accordance with the constitution of the Competition.</p> <p>“Club” means a club for the time being in membership of the Competition.</p> <p>“Competition” means the Suffolk &amp; Ipswich League.</p> <p>“Competition Match” means any match played or to be played under the jurisdiction of the Competition.</p> <p>“Contract Player” means any Player (other than a Player on a Scholarship) who is eligible to play under a written contract of employment with a Club.</p> <p>“Deposit” means a sum of money deposited with the Competition as part of the requirements of membership of the Competition.</p> <p>“Fees Tariff” means a list of fees approved by the Clubs at a general meeting to be levied by the Management Committee for any matters for which fees are payable under the Rules, as set out at Schedule A.</p> <p>“Fines Tariff” means a list of fines approved by the Clubs at a general meeting to be levied by the Management Committee for any breach of the Rules, as set out at Schedule A.</p> <p>“Ground” means the ground on which the Club’s Team(s) plays its Competition Matches.</p> <p>“Management Committee” means in the case of a Competition which is an unincorporated association the management committee elected to manage the running of the Competition and where the Competition is incorporated it means the Board of Directors appointed in accordance with the articles of association of that company.</p> <p>“Match Officials” means the referee, the assistant referees and any fourth official appointed to a Competition Match.</p> <p>“Non Contract Player” means any Player (other than a Player on a Scholarship) who is eligible to play for a Club but has not entered into a written contract of employment.</p> <p>“Officer” means an individual who is appointed or elected to a position in a Club or Competition which requires that individual to make day to day decisions.</p> <p>“Participant” shall have the same meaning as set out in the rules of The FA from time to time.</p> <p>“Player” means any Contract Player, Non Contract Player or other player who plays or who is eligible to play for a Club.</p> <p>“Player Registration System” means The FA system to register players as determined by The FA from time to time.</p> <p>“Playing Season” means the period between the date on which the first competitive fixture in the Competition is played each year until the date on which the last competitive fixture in the Competition is played.</p> <p>“Rules” means these rules under which the Competition is administered.</p> <p>“Sanctioning Authority” means [The FA] [the.....County Football Association Limited].</p> <p>“Scholarship” means a Scholarship as defined in The FA rules.</p> <p>“Season” means the period of time between one AGM and the next AGM</p> <p>“Secretary” means such person or persons appointed or elected to carry out the administration of the Competition.</p> <p>“SGM” means a special general meeting held in accordance with the constitution of the Competition.</p> <p>“Team” means a team affiliated to a Club, including where a Club provides more than one team in the Competition in accordance with the Rules.</p> <p>“The FA” means The Football Association Limited.</p> <p>“Virtual Meetings” means meetings held electronically</p> <p>“written” or “in writing” means the representation or reproduction of words or symbols or other information in a visible form by any method or combination of methods, whether sent or supplied in electronic form or otherwise.</p>
1.B	<p>Unless stated otherwise, terms referring to natural persons are applicable to both genders. Any term in the singular applies to the plural and also the other way around</p>

**GOVERNANCE RULES**

**2. COMPETITION NAME, CONSTITUTION**

2.A	The Competition will be known as Suffolk & Ipswich League (or such other name as the Competition may adopt). The Clubs participating in the Competition must be members of the Competition. A Club which ceases to exist or which ceases to be entitled to play in the Competition for any reason whatsoever shall automatically cease to be a member of the Competition.
2.B	This Competition shall consist of not more than 100 Clubs approved by the Sanctioning Authority.
2.C	The geographical area covered by the Competition membership shall be 40 mile radius of Stowmarket and within the county of Suffolk.
2.D	The administration of the Competition under these Rules will be carried out by the Management Committee in accordance with the rules, regulations and policies of The FA.
2.E	All Clubs shall adhere to the Rules. Every Club shall be deemed, as a member of the Competition to have accepted the Rules and to have agreed to abide by the decisions of the Management Committee in relation to them subject to the provisions of Rule 7.
2.F	The Rules are taken from the Standard Code of Rules (the “Standard Code”) determined by The FA from time to time. In the event of any omissions from the Standard Code then the requirements of the Standard Code shall be deemed to apply to the Competition.
2.G	<p>1. All Clubs must be affiliated to an Affiliated Association and their names and particulars shall be returned annually by the appointed date in a manner prescribed by the Sanctioning Authority and must have a constitution approved by the Sanctioning Authority. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.</p> <p>2. This Competition shall apply annually for sanction to the Sanctioning Authority and the constituent Teams of Clubs may be grouped in divisions, each not exceeding 16 in number.</p>
2.H	<p>Inclusivity and Non-discrimination:</p> <ol style="list-style-type: none"> <li>1. The Competition and each Club must be committed to promoting inclusivity and to eliminating all forms of discrimination and should abide and adhere to The FA Equality Policy and any legislative requirements (including those contained in the Equality Act 2010).</li> <li>2. This Competition and each Club must make every effort to promote equality by treating people fairly and with respect, by recognising that inequalities may exist, by taking steps to address them and by providing access and opportunities for all members of the community, irrespective of age, gender, gender reassignment, sexual orientation, marital status, race, nationality, ethnic origin, colour, religion or belief, ability or disability or otherwise.</li> <li>3. Any alleged breach of the Equality Act 2010 legislation must be referred to the appropriate Sanctioning Authority for investigation.</li> </ol>
2.I	<p>Clubs must comply with the provisions of any initiatives of The FA which are adopted by the Competition including, but not limited to, England Football Accredited and RESPECT programmes. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.</p> <p>(A.R.2(I)1) As an FA England Football Accreditation League this Competition requires all its Clubs to have achieved FA England Football Accreditation League status by 2022. Existing clubs must have their England Football Accreditation award in place at the start of every season. New Clubs have until the end of the year after they join (ie by 31<sup>st</sup> December following the AGM) to achieve the England Football Accreditation award. The League has the right to refuse membership to a Club if it fails to demonstrate commitment to achieving the award.</p> <p>This Competition and its Clubs shall support the FA’s Respect programme. As such it recognises that everyone in football has a collective responsibility to create a fair, safe and enjoyable environment in which the game can take place. A Respect League values the contribution of match officials, players and spectators and ensures that they are treated with courtesy and fairness by opposing players, club officials and spectators. The League and its Clubs will seek to play fixtures in a fair, competitive but not antagonistic environment.</p>
2.J	All Participants shall abide by The Football Association Regulations for Safeguarding Children and Regulations for Safeguarding Adults at Risk as determined by The FA from time to time.

2.K	Clubs shall not enter any of their Teams playing in the Competition in any other competitions (with the exception of FA and County FA Competitions) except with the written consent of the Management Committee. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
2.L	At the AGM or an SGM called for the purpose, a majority of the delegates present shall have power to decide or adjust the constitution of the divisions at their discretion. When necessary this Rule shall take precedence over Rule 22.
2.M	<p>Only one Team from a Club <u>shall be permitted</u> to participate in <u>a single</u> division unless there is no viable alternative because of logistical issues and/or reasons linked to participation and geographical boundaries in which case the Competition will obtain the prior approval of the Sanctioning Authority. This Competition will ensure that, where permission is given, Teams from a Club operating in the same division are run as separate entities with no interchange of players other than by transfers of registration in accordance with these Rules.</p> <p>(A.R.2N) Only bona fide first teams of Member Clubs shall be allowed to play in the Senior Division, Division 1</p> <p>(A.R.2.0) Teams in Divisions 2 to 6, and 'A' teams of member Clubs &amp; teams from Step 4, 5 &amp; 6 meeting the Ground and Headquarters in the County of Suffolk requirement. They will be arranged in five Divisions as decided at the Annual General Meeting.</p> <p>(A.R.2P) The headquarters of the Competition shall be at the office of the General Secretary.</p>
<b>3. CLUB NAME</b>	
3.A	<p>Any Club wishing to change its name must obtain permission from the Sanctioning Authority following consultation with the Competition. In the event that permission is granted, the Club must advise the Competition Secretary. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.</p> <p>A.R.3.1) Clubs must obtain permission from the League of any change of venue for its matches. Matches must not be played on pitches that have not been approved by the Competition</p>
<b>4. ENTRY FEE, SUBSCRIPTION, DEPOSIT</b>	
4.A	<p>Applications by Clubs for admission to the Competition or the entry of an additional Team(s) from the same Club must be made in writing to the Secretary by 1<sup>st</sup> May and must be accompanied by an Entry Fee for each Team as set out in the Fees Tariff, which shall be returned in the event of non-election.</p> <p>Applications , of which due notice has been given, will be received at the AGM or an SGM if confirmed by a majority of the accredited voting members present.</p> <p>When Rule 22.B is applied or a Team seeks a transfer or, is compulsorily transferred to another division, no Entry Fee shall be payable</p>
4.B	The annual subscription shall be payable, in accordance with the Fees Tariff for each team-payable—at a date agreed at the AGM or set by the Competition. Each instalment must be paid by 15 <sup>th</sup> July, 30 <sup>th</sup> September and 31 <sup>st</sup> December. Clubs failing to pay any of the three payments by the required dates shall be fined as set out in the Fees Tariff.
4.C	In the event of any issue concerning the membership of any Club with the Competition the Management Committee may require a Deposit to be paid (in accordance with the Fees Tariff) by or on behalf of the Club on such terms and for such period as it may in its entire discretion think fit. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
4.D	A Club shall not participate in this Competition until the entry fee, annual subscription and deposit (if required) have been paid.

4.E	Clubs must advise the Secretary annually in writing by 15 <sup>th</sup> July of its Sanctioning Authority affiliation number for the forthcoming Playing Season. Clubs must advise the Secretary in writing, or on the prescribed form, of details of its headquarters, its Officers and any other information required by the Competition two weeks before the AGM. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
<b>5. MANAGEMENT, NOMINATION, ELECTION</b>	
5.A	The Management Committee shall comprise the Officers of the Competition and 12 members who shall all be elected at the AGM.
5.B	Retiring Officers shall be eligible to become candidates for re-election without nomination provided that the Officer notifies the Secretary in writing not later than May Management Committee Meeting in each year. All other candidates for election as Officers of the Competition or members of the Management Committee shall be nominated to the Secretary in writing, signed by the secretaries of two Clubs, not later than May Management Committee Meeting in each year. Names of the candidates for election shall be circulated with the notice of the AGM. In the event of there being no nomination for any office by the date stated in the earlier part of this Rule, nominations may be received at the AGM.
5.C	The Management Committee shall meet a minimum of twice a season or as and when required, On receiving a requisition signed by two-thirds (2/3) of the members of the Management Committee the Secretary shall convene a meeting of the Management Committee.
5.D	Except where otherwise mentioned all communications shall be addressed to the Secretary who shall conduct the correspondence of the Competition and keep a record of its proceedings.
5.E	All communications received from Clubs must be conducted through their Officers and sent to the Secretary. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
<b>6. POWERS OF MANAGEMENT</b>	
6.A	The Management Committee may appoint sub-committees and delegate such of their powers as they deem necessary. The decisions of all sub-committees shall be reported to the Management Committee for ratification. The Management Committee shall have power to deal only with matters within the Competition and not for any matters of misconduct that are under the jurisdiction of The FA or Affiliated Association.
6.B	Subject to the permission of the Sanctioning Authority having been obtained, the Management Committee may order a match or matches to be played each Season, the proceeds to be devoted to the funds of the Competition and, if necessary, may call on each Club to contribute equally such sums as may be necessary to meet any deficiency at the end of the Season.
6.C	Each member of the Management Committee shall have the right to attend and vote at all Management Committee meetings and have one vote at all such meetings but no member shall be allowed to vote on any matters directly relating to that member or to the Club so represented or where there may be a conflict of interest. (This shall also apply to the procedure of any sub-committee) AR 6(C) Absence from 3 consecutive committee meetings without apologies and the member loses the right to serve
6.D	In the event of the voting being equal on any matter, the Chair shall have a second or casting vote.

6.E	<p>The Management Committee shall have powers to apply, act upon and enforce these Rules and shall also have jurisdiction over all matters affecting the Competition. Any action by the Competition must be taken within 28 days of the Competition being notified.</p> <p>With the exception of Rules 6.J, 8.H, and 9, for all alleged breaches of a Rule the Management Committee shall issue a formal written charge to the Club concerned. The Club charged shall be given 7 days from the date of notification of the charge to reply. In such reply a Club may:</p> <ol style="list-style-type: none"> <li>1. Accept the charge and /or submit in writing a case of mitigation for consideration by the Management Committee; or</li> <li>2. Accept the charge and notify the Competition Secretary that it wishes to put its case of mitigation at a hearing before the Management Committee; or</li> <li>3. Deny the charge and submit in writing supporting evidence for consideration by the Management Committee; or</li> <li>4. Deny the charge and notify the Competition Secretary that it wishes to have a hearing before the Management Committee.</li> </ol> <p>Where the Club charged fails to respond within 7 days, the Management Committee shall determine the charge in such manner and upon such evidence as it considers appropriate.</p> <p>Having considered the reply of the Club (whether in writing or at a hearing), the Management Committee shall make its decision and, in the event that the charge is accepted or, proven, decide on the appropriate penalty (with reference to the Fines Tariff where applicable).</p> <p>Where required, hearings shall take place as soon as reasonably practicable following receipt of the reply of the Club as more fully set out above.</p> <p>With the exception of Teams playing at Regional NLS Feeder League of the National League System, the maximum fine permitted for any breach of a Rule is £250 and, when setting any fine, the Management Committee must ensure that the penalty is proportional to the offence; taking into account any mitigating circumstances.</p> <p>The maximum fine permitted for a breach of a Rule by a Team playing at Regional NLS Feeder League level is £500.</p> <p>No Participant under the age of 18 can be fined.</p> <p>All breaches of the Laws of the Game, or the Rules and Regulations of The FA shall be dealt with in accordance with FA Rules by the appropriate sanctioning Association.</p>
6.F	<p>All decisions of the Management Committee shall be binding subject to the right of appeal in accordance with Rule 7.</p> <p>Decisions of the Management Committee must be notified in writing to those concerned within 7 days.</p>
6.G	<p>A minimum of 50% of its members shall constitute a quorum for the transaction of business by the Management Committee or any of its sub-committees</p>
6.H	<p>The Management Committee, as it may deem necessary, shall have power to fill any vacancies that may occur in their number.</p>
6.I	<p>A Club must comply with an order or instruction of the Management Committee and must attend to the business and/or the correspondence of the Competition to the satisfaction of the Management Committee. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.</p>

6.J	Subject to the Club's right of appeal in accordance with Rule 7 below, all fines and charges must be paid within 14 days of the date of notification of the decision. Any Club failing to do so will be fined in accordance with the Fines Tariff. Further failure to pay the fine including the additional fine within a further 14 days will result in fixtures being withdrawn until such time as the outstanding fines are paid.
6.K	A member of the Management Committee appointed by the Competition to attend a meeting or Competition Match may have any reasonable expenses incurred refunded by the Competition.
6.L	The Management Committee shall have the power to fill any vacancy that may occur in the membership of the Competition between the AGM or SGM called to decide the constitution and the commencement of the Playing Season, , subject to the provisions of the National League System Regulations or Women's Football Pyramid Regulations (which shall take precedence if applicable).
6.M	<p>The business of the Competition as determined by the Management Committee may be transacted by electronic mail.</p> <p>(A.R.6M) By ballot, annually, the records of one Senior Club and one Club from each of the Junior Divisions will be required for inspection by the Management Committee. These records to consist of those that the Football Association and this League require by their Rules and must include a record of meeting minutes, financial books including back up documents and bank statements, record of players, including matches played, together with proof of Club AGM and audited accounts.</p> <p>(A.R.6N) All new Clubs entering the League will be required to have their records inspected during their first season by the Management Committee. The records should be consistent with the requirements set out under Rule 5(M).</p> <p>(A.R.6.O) Clubs must seek the approval of the League as well as the Suffolk County Football Association for any kit sponsorship arrangements. Permission will be required for each new arrangement. Clubs failing to conform may be fined up to £40.</p> <p>(A.R.6P) A newly appointed Club Chair or Secretary or in the case of a new Club both Chair and Secretary shall attend a League briefing given by the Officers of the League, normally on the Thursday following the AGM. The aim of the meeting is to enable new Chairs and Secretaries to carry out their duties in as efficient a manner as possible. Failure to attend such a meeting will lead to a fine of £50.</p>
<b>7. PROTESTS, CLAIMS, COMPLAINTS, APPEALS</b>	
7.A	<p>1. All questions of eligibility, qualification of Players or interpretations of the Rules shall be referred to the Management Committee or a sub-committee duly appointed by the Management Committee.</p> <p>2. Objections relevant to the dimensions of the pitch, goals, flag posts or other facilities will not be entertained by the Management Committee unless a protest is lodged with the referee prior to the commencement of the Match.</p>
7.B	Except in cases where the Management Committee decide that there are special circumstances, protests and complaints (which must contain full particulars of the grounds upon which they are founded) must be lodged with the Secretary within 7 days (excluding Sundays) of the Competition Match or occurrence to which they refer. A protest or complaint shall not be withdrawn except by permission of the Management Committee. A member of the Management Committee who is a member of any Club involved shall not be present (except as a witness or representative of his Club) when such protest or complaint is being determined.
7.C	No protest of whatever kind shall be considered by the Management Committee unless the complaining Club shall have deposited with the Secretary a sum in accordance with the Fees Tariff. This may be forfeited in whole or in part in the event of the complaining or protesting Club losing its case. The Competition shall have power to order the defaulting Club or the Club making a losing or frivolous protest or complaint to pay the expenses of the inquiry or to order that the costs to be shared by the parties.
7.D	<p>All parties to a protest or complaint must receive a copy of the submission and must be afforded an opportunity to make a statement at least 7 days before the protest or complaint being heard.</p> <p>1. All parties must have received a minimum of 7 days' notice of the hearing should they be instructed to attend.</p> <p>2. Should a Club elect to state its case in person then it should indicate such when forwarding the written response.</p>
7.E	The Management Committee shall also have power to compel any party to the protest to pay such expenses as the Management Committee shall direct.

7.F	<p>Any appeal against a decision of the Management Committee must be lodged with the Sanctioning Authority within 14 days of the posting of the written notification of the decision causing the appeal, accompanied by a fee (as set out in the Fees Tariff), which may be forfeited in the event of the appeal not being upheld. A copy of the appeal must also be sent to the Secretary. The procedure for the appeal shall be determined by the Sanctioning Authority, and the Sanctioning Authority may (but is not obliged to):</p> <ol style="list-style-type: none"> <li>1. invite submissions by the parties involved;</li> <li>2. convene a hearing to hear the appeal;</li> <li>3. permit new evidence; or</li> <li>4. impose appropriate deadlines.</li> </ol> <p>Any appeal shall not involve a rehearing of the evidence considered by the Management Committee.</p>
7.G	<p>No appeal can be lodged against a decision taken at an AGM or SGM unless this is on the ground of unconstitutional conduct</p>
7.H	<p>All protests, claims or complaints relating to these Rules and appeals arising from a Player's contract shall be heard and determined by the Management Committee, or a sub-committee duly appointed by the Management Committee. The Clubs or Players protesting, appealing, claiming or complaining must send a copy of such protest, appeal, claim or complaint and deposit a fee (as set out in the Fees Tariff) which shall be forfeited in the event of the protest, appeal, claim or complaint not being upheld, and in these circumstances may, in addition, be ordered to pay the costs at the direction of the Management Committee.</p> <p>All such protests, claims, complaints and appeals must be received in writing by the Secretary within 14 days of the event or decision causing any of these to be submitted.</p>
<p><b>8. ANNUAL GENERAL MEETING</b></p>	
8.A	<p>The AGM shall be held not later than [ ] in each year. At this meeting the following business shall be transacted provided that at least [ ] members are present and entitled to vote:-</p> <ol style="list-style-type: none"> <li>1. Confirm-the minutes of the last AGM.</li> <li>2. Adopt the annual report, balance sheet and statement of accounts from the previous season or accounting period.</li> <li>3. Election of Clubs to fill vacancies.</li> <li>4. Constitution of the Competition for the ensuing Season.</li> <li>5. Election of Competition Officers and Management Committee members.</li> <li>6. Appointment of auditors/verifiers..</li> <li>7. Alteration of Rules, if any (see Rule 14).</li> <li>8. Agree the date for the beginning of the Playing Season and kick off times applicable to the Competition.</li> <li>9. Agree the date for the end of the Playing Season (save for Regional NLS Feeder League which shall be determined by The FA).</li> <li>10. Other business of which due notice shall have been given and accepted by the Chair as being relevant to an AGM.</li> </ol>
8.B	<p>A copy of the duly audited/verified balance sheet, statement of accounts and agenda shall be forwarded to each Club at least 14 days prior to the meeting, together with any proposed Rule changes.</p>
8.C	<p>A signed copy of the duly audited/verified balance sheet and statement of accounts shall be sent to the Sanctioning Authority within 14 days of its adoption by the AGM.</p>
8.D	<p>Each Club shall be empowered to send two delegates to an AGM. Each Club shall be entitled to one vote only. 14 days' notice shall be given of any AGM.</p>
8.E	<p>Clubs who have withdrawn their membership of the Competition during the Playing Season being concluded or who are not continuing membership shall be entitled to attend but shall vote only on matters relating to the Season being concluded. <i>This provision will not apply to Clubs expelled in accordance with Rule 12</i></p>
8.F	<p>All voting shall be conducted by a show of hands, or count of email or virtual responses (for virtual meetings), unless a ballot be demanded by at least 50% of the delegates qualified to vote or the Chair so decides.</p>



8.G	No individual shall be entitled to vote on behalf of more than one Club.
8.H	Any continuing Club must be represented at the AGM. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
8.I	Officers of the Competition and Management Committee members shall be entitled to attend and vote at an AGM, but cannot also cast a vote on behalf of a club (See Rule 8.G)
8.J	Where a Competition is an incorporated entity, the Officers of the Competition shall ensure that the Articles of Association of the Competition are consistent with the requirements of these Rules.

## 9. SPECIAL GENERAL MEETINGS

9.A	On receiving a requisition signed by two-thirds (2/3) of the Clubs in membership the Secretary shall call an SGM.
9B	The Management Committee may call an SGM at any time
9C	At least 7 days' notice shall be given of a meeting under this Rule, together with an agenda of the business to be transacted at such meeting.
9D	Each Club shall be empowered to send two delegates to all SGMs. Each Club shall be entitled to one vote only.
9E	Any Club failing to be represented at an SGM shall be fined in accordance with the Fines Tariff.
9F	Officers of the Competition and Management Committee members shall be entitled to attend and vote at all SGMs, but cannot also cast a vote on behalf of a club (See Rule 9.D)

## 10. AGREEMENT TO BE SIGNED

## MATCH RELATED RULES

<b>18. QUALIFICATION OF PLAYERS</b>	
18.A	<p>A Player is one who, being in all other respects eligible, has: Registered through the Player Registration System and received approval from the Competition. NB All players must be registered for all of their teams in the Competition</p> <p>Any registration that is not fully and correctly completed will be returned to the Club unprocessed and the player classed as unregistered. If a Club attempts to register a player via the Player Registration System but does not fully and correctly complete the necessary information via the Player Registration System the registration will not be processed.</p> <p>For Clubs registering Players by the Player Registration System, Clubs must access the Player Registration System in order to complete the registration process.</p> <p>Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.</p> <p>The weekly deadline for registrations and transfers is 9pm on Thursdays</p>
18.B	<ol style="list-style-type: none"> <li>1. Contract players are not permitted in this Competition with the exception of those Players who are registered under Contract with the same Club who have a team operating at Steps 1 to 6 of the National League System. or Tiers 1-4 of the Women Pyramid System.</li> <li>2. It is the responsibility of each Club to ensure that any Player registered to the Club has, where necessary, the required International Transfer Certificate. Clearance is required for any Player aged 10 and over crossing borders including Wales, Scotland and Ireland.</li> <li>3. Each team must have at least 15 Players registered 3 days before the start of each Playing Season. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.</li> <li>4. 18.D	<p>A fee as set out in the Fees Tariff shall be paid by each Club/Team for each Player registered.</p>

18.E	<p>The Management Committee shall decide all registration disputes.</p> <p>In the event of a player signing a registration form or having a registration submitted for more than one Club, priority of registration shall decide for which Club the Player shall be registered. The Secretary shall notify the Club last applying to register the player of the fact of the previous registration.</p>
18.F	<p>It shall be a breach of Rule for a Player to:</p> <ol style="list-style-type: none"> <li>1. Play for more than one Club in the Competition in the same Playing Season without first being transferred.</li> <li>2. Having registered for one Club in the Competition, register for another Club in the Competition in that Playing Season except for the purpose of a transfer, <i>or where the Competition adopts rule 18.P</i></li> <li>3. Submit a signed registration form as per Rule 18 A.2 or submit a registration through the Player Registration System -that the Player had willfully neglected to accurately or fully complete.</li> </ol> <p>Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.</p>
18.G	<ol style="list-style-type: none"> <li>1. The Management Committee shall have the power to accept the registration of any Player subject to the provisions of Rules 18.G.2 and 18.G.3 below.</li> <li>2. The Management Committee shall have power to refuse, cancel or suspend the registration of any Player or may fine any Player, at their discretion (in accordance with the Fines Tariff) who has been charged and found guilty of registration irregularities (subject to Rule 7).</li> <li>3. The Management Committee shall have power to make application to refuse or cancel the registration of any Player charged and found guilty of undesirable conduct (subject to Rule 7) subject to the right of appeal to the Sanctioning Authority. Application should be made to the parent County of the Club the Player is registered or intending to be registered with.</li> </ol> <p>Undesirable conduct shall mean an incident of repeated proven misconduct, which may deter a Participant from being involved in this Competition.</p> <ol style="list-style-type: none"> <li>4. A Player who has previously had a registration removed in accordance with Rule 18.G.3 but has a registration accepted at the expiry of exclusion will be considered to be under a probationary period of 12 months. Whilst under a probationary period, should the Player commit a further act of proven misconduct under the jurisdiction of the Competition, (excluding standard dismissals), the Competition may consider a further charge of bringing the Competition into disrepute.</li> </ol> <p><i>(Note: Action under Rule 18.G.3 shall not be taken against a Player for misconduct until the matter has been dealt with by the Sanctioning Authority, and then only in cases of the Player bringing the Competition into disrepute and will in any event be subject to an appeal to the Sanctioning Authority or The FA. All decisions must include the period of restriction. For the purpose of this Rule, bringing the Competition into disrepute can only be considered where the Player has received in excess of 112 days' suspension, or 10 matches in match based discipline, in any competition (and is not restricted to the Competition) in a period of two years or less from the date of the first offence.)</i></p>
18.H	<p>Subject to compliance with FA Rule C when a Club wishes to register a player who is already registered with another club it shall submit a transfer notification to the Competition via the Player Registration System. –A fee as set out in the Fees Tariff [<i>will/may</i>] be required.</p> <p>Such transfer shall be referred by the Competition to the club for which the player is registered. Should this club object to the transfer it should state its objections in writing to the Competition and to the player concerned within 3 days of receipt of the notification. 18.K	A Player shall not be eligible to play for a Team in any special championship, promotion or relegation deciding Competition Match (as specified in Rule-(22.A) unless the Player has played [ ] Competition Matches for that Team in the current Playing Season.
18.L.	A Team shall not include more than [1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11 ] Players who has/have taken part in [ ] or more senior Competition Matches during the current Playing Season unless a period of 21 days has elapsed since they last played. For the purpose of this Rule a senior competition(s) is/are [ ].  Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
18.M	<ol style="list-style-type: none"> <li>1. Subject to Rule 18.M.2 any Club found to have played an ineligible Player in a Competition Match or Matches where points are awarded shall have the points gained from that Competition Match deducted from its record, up to a maximum of 12 points, and have levied upon it a fine (in accordance with the Fines Tariff). ARM 1a If a player is suspended and plays and is fined by SFA -nofine but loss of points (double jeopardy)</li> <li>2. The Management Committee may vary the sanction as relates to the deduction of points set out at Rule-18.M.1 only in circumstances where the ineligibility is due to the failure to obtain an International Transfer Certificate or where the ineligibility is related to the Player's status.  Where a Club is found to have played an ineligible Player in accordance with Rule 18.M.1 above, the Management Committee may also, at its discretion order one or more of the following (if appropriate): <ol style="list-style-type: none"> <li>a) Award the points available in the Competition Match in question to the opponents, subject to the Competition Match not being ordered to be replayed; or</li> <li>b) Levy penalty points against the Club in default; or</li> <li>c) Order that such Competition Match or Matches be replayed (on such terms as are decided by the Management Committee).</li> </ol> </li> </ol>
18.N	The following clause applies to Competitions involving Players in full-time secondary education: <ol style="list-style-type: none"> <li>1. Priority must be given at all times to activities of schools and school organisations. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.</li> <li>2. The availability of children and young people must be cleared with the Head Teachers or Principals (except for Sunday leagues competitions).</li> <li>3. To play open age football the player must have achieved the age of 16.</li> </ol>
18.O	A Player who has played for a Team in a higher division in that Playing Season shall be eligible to play in a lower division by permission of the Management Committee. NB This relates to a first team folding and a reserve team wishing to carry on.
<b>19. CLUB COLOURS</b>	
19	Every team must register the colour of its shirts and shorts with the Secretary by 15 <sup>th</sup> June and the Competition Secretary shall decide as to their suitability.
19.B	Any team changing its colours during the Playing Season must notify the Competition Secretary immediately.
19.C	Goalkeepers must wear colours which distinguish them from all other Players and the Match Officials.
19.D	No Player, including the goalkeeper, shall be permitted to wear black or very dark shirts.

19.E	Any Team not being able to play in its normal colours as registered with the Competition shall notify its opponents of the colours in which they will play (including the colours of the goalkeepers jersey) at least 4 days before the Competition Match.
19.F	If, in the opinion of the referee, two Teams have the same or similar colours, the [ <i>away/home</i> ] Team shall make the change. Should a Team delay the scheduled time of kick off for a Competition Match by not having a change of colours they will be fined in accordance with the Fines Tariff.
19.G	<p>Shirts must all be numbered and no two shirts shall have the same number, failing which a fine will be levied in accordance with the Fines Tariff</p> <p>The General Secretary of the Competition may request shirts to be submitted if complaints are received as to lack of distinguishing colours, and the Management Committee may refuse to permit any shirts or shorts as they think fit</p>
<b>20. PLAYING SEASON. CONDITIONS OF PLAY, TIMES OF KICK-OFF. POSTPONEMENTS. SUBSTITUTES</b>	

20.A All Competition Matches shall be played in accordance with the Laws of the Game as determined by the International Football Association Board.

Clubs must take all reasonable precautions to keep their Grounds in a playable condition. All Competition Matches shall be played on pitches deemed suitable by the Management Committee. If through any fault of the home Team a match has to be replayed, the Management Committee shall have power to order the venue to be changed.

The Management Committee shall have power to decide whether a pitch and/or facilities are suitable for Competition Matches and to order the Club concerned to play its Competition Match(es) on another ground.

Artificial Football Turf Pitches (3G) are allowed in this Competition provided they meet the required performance standards and are listed on the FA's Register of Football Turf Pitches - <https://footballfoundation.org.uk/3g-pitch-register>. All Football Turf Pitches used must be tested (by a FIFA accredited test institute) every three years and the results passed to The FA. The FA will give a decision on the suitability for use and add the pitch to the Register.

The home Club is also responsible for advising Participants of footwear requirements when confirming match arrangements in accordance with Rule 20.C.

Within Regional NLS Feeder Leagues, all Competition Matches shall have a duration of 90 minutes. All **other** Competition Matches shall have duration of 90 minutes unless a shorter time (not less than sixty (60) minutes) is mutually arranged by the two Clubs in consultation with the referee prior to the commencement of the match, and in any event shall be of equal halves. Two matches involving the same two Teams can be played on the same day providing the total playing time is not more than 120 minutes.

The times of kick-off shall be agreed at the AGM and can only be altered by the mutual consent of the two competing Clubs and the Competition. Referees must order matches to commence at the appointed time and must report all late starts to the Competition.

The latest times for kicking-off league matches shall normally be (except for evening kick-offs) 2.30pm from August to October and from February to May. 2pm from November to January. League Cup matches will kick off 30 minutes earlier.

The home Team must provide goal nets, corner flags and at least two footballs fit for play and the referee shall make a report to the Competition if not provided. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.

No overhead netting is allowed for 9v9 and 11v11 affiliated matches

Regional NLS Feeder Leagues: Overhead wires used to support pitch divider netting are removed for all affiliated matches at Regional NLS Feeder League level

For those leagues which are not Regional NLS Feeder Leagues: Overhead wires used to support pitch divider netting are ideally removed for affiliated matches but if they cannot be removed then discretion is given to the match official to restart the match in accordance of the laws of the game.

AR 20(A)(1) The Annual General Meeting shall determine the date for the commencement of the season.

Normally, the commencement of the SIL Playing Season shall be as follows: Senior Division, Division 1 & 2 – Second last Saturday in August Other Divisions –fourth Saturday in August

Normally, the end of the Competition shall be the first Saturday in May, but should unforeseen circumstances arise the Management Committee have the right to order an extension of the season but not later than the 3rd Saturday in May.

(A.R.20A.2) After the publication of fixtures for the season thirty-five days notice must be given of closed dates and any request to postpone a fixture. This rule does not apply to Senior Division teams who cannot close dates or postpone a fixture (except if another fixture takes priority) after the publication of the fixtures without the approval of the Fixtures Secretary. Teams can close a maximum of 2 dates during the course of a season.

(A.R.20A.3) From 1st April annually, until the end of the season's competition, unless a Club has closed a date in accordance with Rule A.R.20A.2 the Fixtures Secretary may, by giving at least five days' notice



20.B	<p>Except by permission of the Management Committee all Competition Matches must be played on the dates originally agreed but priority shall be given to The FA and parent County Association Cup Competitions. All other matches must be considered secondary. Clubs may mutually agree to bring forward a Competition match with the consent of the Competition. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.</p> <p>In the case of a revised fixture date, the Clubs must be given by the Competition 5 clear days' notice of the match (unless otherwise mutually agreed).</p>
20.C	<p>An Officer of the home Club must give notice of full particulars of the location of, and access to, the Ground and time of kick-off to the Match Officials and an Officer of the opposing Club at least [ ] clear days prior to the playing of the match. If not so provided, the away Club shall seek such details and report the circumstances to the Competition. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.</p>
20.D	<p>In accordance with the Laws of the Game, the minimum number of Players which will constitute a Team for a Competition Match is 7.</p>

20.E

1. Home and away matches shall be played. In the event of a Club failing to keep its engagement the Management Committee shall have power to impose a fine (in accordance with the Fines Tariff), deduct points from the defaulting Club, award the points from the Competition Match in question to the opponents, order the defaulting Club to pay any reasonable expenses incurred by the opponents or otherwise deal with them except by the award of goals. *Notwithstanding the foregoing home and away provision, the Management Committee shall have power to order a Competition Match to be played on a neutral ground or on the opponent's Ground if they are satisfied that such action is warranted by the circumstances.*

Instead of £60 for a postponed game, £50

(A.R.20E.1) In the event that a home Club's ground is not available for any reason, it is the duty of the home Club to find a suitable alternative with the agreement of the Fixtures Secretary.

(A.R.20E.2) If a match is postponed for ANY reason both Clubs must keep their players available until the Clubs have discussed the cancelled fixture with the Fixtures Secretary. If the Fixtures Secretary is unavailable then the matter should be discussed with another League Officer. If a match is postponed because of an unfit pitch the home club must complete Form SIL1 to reach the Fixtures Secretary within 7 days (Sundays excluded) of the postponement. Any Club failing to make a correct return shall be fined £10.

(A.R.20E.3) Postponed match fines are as follows:-

£150 for all Senior matches

£60 for all other divisions

2. Any Club with more than one Team in the Competition shall always fulfil its fixture, within the Competition, in the following order of precedence:- First Team, Reserve Team, A Team.–
3. Any Club unable to fulfil a fixture or where a Competition Match has been postponed for any reason must, without delay, give notice to the the Competition Fixture Secretary, the secretary of the opposing Club and the Match Officials. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
4. In the event of a Competition Match not being played or being abandoned owing to causes over which neither Club has control, it should be played in its entirety on a date to be mutually agreed by the two Clubs and approved by the Competition Failing such agreement and notification to the {Competition within 7 days the Competition shall have the power to order the Match to be played on or before a given date. Where it is to the advantage of the Competition- the Management Committee shall also be empowered to order the score at the time of an abandonment to stand. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
5. The Management Committee shall review all Competition Matches abandoned in cases where it is consequent upon the conduct of either or both Teams. Where it is to the advantage of the Competition and does no injustice to either Club, the Management Committee shall order the score at the time of the abandonment to stand. In all cases where the Management Committee are satisfied that a –Match was abandoned owing to the conduct of one Team or its Club member(s) they shall award the points for the Match to the opponent. In cases where a Match has been abandoned owing to the conduct of both Teams or their Club member(s), the Management Committee shall rule that neither Team will be awarded any points for that Match and it shall not be replayed. No fine(s) can be applied by the Management Committee for an abandoned Match.

The Management Committee shall review any-Match that has taken place where either or both Teams were under a suspension imposed upon them by The FA or Affiliated Association. In each case the Team that was under suspension would be dealt with in the same manner as if they had participated with ineligible players in accordance with Rule 18.M above. Where both Teams were under suspension the game must be declared null and void and shall not be replayed.

20.F	<p>A Club may at its discretion and in accordance with the Laws of the Game use substitute Players in any Competition Match. A Club may name up to 5 substitute Players of whom not more than 5 may be used..</p> <p>A Player who has been substituted becomes a substitute and may replace a Player at any time subject to the substitution being carried out in accordance with Law 3 of the Laws of Association Football.</p> <p>Where a Competition does allow return substitutes, a –Team may use up to 5 from 5 substitute Players in a Competition Match.</p> <p>The referee [and a representative of the opposing Club] shall be informed of the names of the Players taking part in the Match (including the substitutes) not later than 30 minutes before the start of the Competition Match and a Player not so named may not take part in that Competition Match.</p> <p>A Player who has been named as a substitute before the start of the Competition Match but does not actually play in that game shall not be considered to have been a Player in that Competition Match within the meaning of Rule 18 of this Competition.</p> <p>Sin bins operate in this league.</p>
20.G	<p>The half time interval shall be of 15 minutes' duration, but it shall not exceed 15 minutes. The half time interval may only be altered with the consent of the referee</p>
20.H	<p>The Teams taking part in a Competition Match shall identify a Team captain who shall wear an armband and shall have a responsibility to offer support in the management of the on-field discipline of their teammates. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.</p> <p>AR 20H.1 The Competition shall require all players and club officials to have signed the FA's Respect Codes of Conduct and produce these if so requested by the League Management Committee.</p> <p>Prior to each match the participating teams and officials shall conduct the Respect handshake</p>
<b>21. REPORTING RESULTS</b>	
21.A	<p>The Competition Secretary must receive within 4 days of the date played, the result of each Competition Match in the prescribed manner. This must include the forename(s) and surname of the Team Players (in block letters) and also the referee markings required by Rule 23, or any other information required by the Competition. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.</p>
21.B	<p>The Home Club shall use SMS as directed by the Competition to notify the result of each Competition Match by 6pm. 22.B	<p>Automatic promotion shall be applied for the first 2 Teams and automatic relegation shall be applied for the last 2 Teams in each division except as provided for below subject to the provisions of Rule 2.L.</p> <p>Subject to meeting the necessary ground and administration requirements the following promotions will be applied:-</p> <ul style="list-style-type: none"> <li>• Top two teams in Divisions 1- 6 will be promoted to Senior Division and Divisions 1- 5 as appropriate</li> <li>• Bottom two teams in Senior Division and bottom two teams in Divisions 1-5 will be relegated to Divisions 1-6 as appropriate .</li> </ul> <p>The Management Committee (subject to AGM approval) reserves the right to alter the above in order to equalize numbers in each of the divisions.</p> <ol style="list-style-type: none"> <li>1. Should one or more Teams withdraw from any one division after the Playing Season has commenced an equal number of Teams to those withdrawing in that division shall not be automatically relegated.</li> <li>2. Vacancies occurring after the conclusion of the Playing Season may be filled in any of the following ways: <ol style="list-style-type: none"> <li>a. retention of otherwise relegated Team(s); or</li> <li>b. additional promotion of the next ranked Team(s) from the division below; or</li> <li>c. election.</li> </ol> </li> <li>3. The last 2 Teams in the lowest division shall retire, but be eligible for re-election except as below, and be subject to the conditions of Rule22.B.1 above.</li> <li>4. When a senior Team is relegated to a lower division of which its reserve Team is a member, or entitled to be a member, such reserve Team must accept relegation to, or retain its position in, the next lower division; and should the senior Team be relegated to the lowest division its reserve Team automatically retires from the Competition.</li> <li>5. <p><b>23. MATCH OFFICIALS</b></p>	

23.A	Registered referees (and assistant referees where approved by The FA or County FA) for all Competition Matches shall be appointed in a manner approved by the Management Committee and by the Sanctioning Authority.

In the event that such circumstances prevail, Clubs should comply with procedures provided for in the document published by The FA “Recommended procedure for the guidance of Clubs and Referees in determining the suitability of grounds in adverse weather conditions”. Should the ground be declared unfit it is the responsibility of the home Club to immediately advise the Competition, the Appointing Authority, the visiting Club and the Match Officials.</p> <p><u>For those leagues which are not Regional NLS Feeder Leagues</u>: The appointed referee shall have power to decide as to the fitness of the Ground in all Competition Matches and that decision shall be final, subject to the determination of the Local Authority or the owners of a Ground, which must be accepted.</p>
23.E	<p>Subject to any limits/provisions laid down by the Sanctioning Authority, Match Officials appointed under this Rule shall be paid a match fee in accordance with the Fees Tariff [<i>and travel expenses of [ ] per mile/ or inclusive of travel expenses</i>].</p> <p>Match Officials will be paid their fees by the home Club immediately after the Competition Match. Failure to do so may result in them being reported to the appropriate County Association</p> <p>(AR 23 G.2) It mandatory that the Referee gives each team a ‘crime sheet’ after every match.</p>

23.J	The referee shall submit a report form, supplied by the Competition, giving the result of the Competition Match, the number of Players in each Team and the time of kick-off to the (Registration) Secretary within two days of the Competition Match.
23.K	Match Officials shall comply with the provisions of any initiatives of The FA and/or Sanctioning Authority adopted by the Competition.
<b>SPORTSMANSHIP AWARDS</b>	
23L	The League publishes a Sportsmanship Award Table based on the following: - red & yellow cards issued by Referees and misconduct reports against your player(s) and club. Details of the scheme are issued separately. The Club that finishes bottom (Senior and Junior combined) at the end of the season shall be fined £150, suspended to the end of the following season. The fine would be withdrawn if the Club has an overall placement improvement of at least 10 places. With no such improvement the fine must be paid within 14 days issue of the new season's table and by issue of an invoice.

APPENDIX A - REPRESENTATIVE GAMES AND LEAGUE KNOCK-OUT CUPS

A	<p>The Morrison Freight Cup is for teams in the Senior Division and Divisions 1, plus non reserve sides in Division 2 and first team sides in Division 3 that have a reserve team. Senior Division Clubs will enter the last 32 stage.</p> <p>The Reserve Cup is for Reserve teams whose first team is in Morrison Freight Cup.</p> <p>The Divisional Cup is for teams in Divisions 3- 6 not playing in the Morrison Freight Cup or the Reserve Cup.</p>
B	Clubs can elect not to enter a team into their designated League Cup competition. Any such election is to be made before the first cup draws are made and will be subject to a £35 fee.
C	The rules of these competitions are in accordance with the Rules of the Suffolk & Ipswich Football League and the Laws of the Game with the exception of the following amendments:
D	All matches excluding the Finals to be played on the ground of the first drawn Club, unless not possible for weather or unsuitable facilities. Should the first drawn Club's pitch be unfit for play then they should make every endeavour to find an alternative venue. Should their opponent's pitch be available, fit for play and offered with no pitch hire fee, then if the first drawn team decline to switch venue they may be charged with failing to fulfil the fixture and, if found guilty, removed from the competition.
E	Attempts should be made to use a cordoned off pitch in all Morrison Freight Cup matches from the 3rd Round.
F	The Suffolk & Ipswich League will make all arrangements for the Finals.
G	A team not fulfilling its drawn cup match on the scheduled date shall forfeit the game to its opponents and be fined £150 (Senior team) or £60 (Junior team). This does not apply if the fixture was postponed owing to adverse weather or ground conditions or because the team was involved in a SCFA competition.
H	All matches will be played to conclusion on the day. If the scores are equal after 90 minutes, the match will be decided on penalties in accordance with International Board ruling on the subject. A Club causing a match to be unfinished in accordance with Rules will be 'struck out' of the competition.
I	Times of Kick-Off: August to October, February to May 2.00pm November to January 1.30pm
J	Referees Expenses as Rule 22(F). Fees as follows:- Morrison Freight Cup up until senior teams enter - £40 Morrison Freight Cup 3rd and subsequent Rounds, excluding Final - £50, except where Junior clubs play each other when fee will be £40 Reserves, and Divisional Cup, excluding Final - £40 Assistant Referees in all League Cups up to 3rd Round - £30 Assistant Referees in all League Cups 3rd and subsequent Rounds, excluding Final - £35

O	Qualification of players - In the Morrison Freight Cup no player shall play for more than one Club team per season in this competition, except for a goalkeeper in an emergency. The goalkeeper must play in that position and permission for this must be obtained from the Players' Registration Secretary prior to the game. Player promotion from the Reserve Cup or Divisional Cup is permissible but the player cannot revert back to the lower competition after obtaining a Morrison Freight Cup qualification. The playing of any ineligible player will lead to the guilty team being excluded from the competition and fined £30.
P	In the Reserve Cup no player shall play for more than one Club team per season in this competition, except for a goalkeeper in an emergency. The goalkeeper must play in that position and permission for this must be obtained from the Players' Registration Secretary prior to the game. Player promotion from the Divisional Cup is permissible but the player cannot revert back to the lower competition after obtaining Intermediate Cup qualification. The playing of any ineligible player will lead to the guilty team being excluded from the competition and fined £30.
Q	In the Divisional Cup no player shall play for more than one Club team per season in this competition, nor have played in the Morrison Freight Cup or Reserve Cup, except for a goalkeeper in an emergency the goalkeeper must play in that position and permission for this must be obtained from the Players' Registration Secretary prior to the game. The playing of any ineligible player will lead to the guilty team being excluded from the competition and fined £30.
	APPENDIX B STAR RATINGS
	Four Star Rating – Senior Division
1	Playing strength to Senior standard (Clubs should finish first or second in Division One – any other application subject to approval by the Management Committee)

2	Clubs must provide a separate dressing room for each team, minimum dimensions of 12sq metres excluding showers. Each dressing room to include a minimum of 3 shower heads ensuite, but at least adjoining within the players area. Toilet facilities including hand basin to be available in the players area for each team. A separate dressing room for match officials to include a minimum of one shower head and toilet facilities ensuite or adjoining. toilet facilities separate to those used by the players and match officials must be available for public use within the ground. Shared toilet and shower facilities are not acceptable.
3	The playing area of the pitch shall be of grass (see rule 20A) and shall be to the Suffolk County Football Association Senior Cup rules (100 metres x 64 metres minimum). The playing area shall be completely cordoned off on all four sides by rope and/or railings which all spectators must be behind. The ropes or railings must be no closer to the touch line than 2 metres.
4	A minimum of 20 metres between pitches must be available when a Senior match is being played.
5	A proven sound administration
6	A Committee to deal efficiently with Club matters with a member to welcome visiting teams and officials.
7	Complimentary refreshments to be provided to players and match officials at halftime, while refreshments, tea, coffee etc. must be made available for spectators.
8	First aid equipment must be available at all matches. It is recommended that all Senior Clubs have a qualified First Aider.
9	The players starting the match are allowed to wear any numbered shirt. All players must wear the number allocated to them on the team sheet. Shirts and shorts must be distinctive from their opponents.  Referees are allowed to wear a different coloured shirt, but if they are on a match with 3 appointed officials, ALL officials must wear the same colour. Referees to carry a black shirt in case their coloured shirt clashes with either team.
10	Teamsheets containing the names of the players intending to be played (which may only be changed in exceptional circumstances for matches in the Senior Division, and from the 3rd round of the Morrison Freight Cup) will be presented to the match referee in the referee's dressing room by both Clubs together, 30 minutes before the stated kick-off time. The four forms shall be signed by a recognised Club Official. An additional copy is made available for the 'Press' and both player's first and surnames must be entered.
11	The home Club shall provide two match balls and will ensure that a suitable football pump and adaptor is at the ground. The home Club will also have available Assistant referee flags.
12	The Technical Area extends 1m on either side of the designated seated area and extends forward up to a distance of 1m from the touch line. In all matches, the number of the Club's players and officials seated on the team benches in the Technical area must not exceed 8. A trainer's hut or dug out to seat a minimum of 8 (0.5 metres per person) must be provided for each team.
13	Clubs failing to retain their listed standards shall be fined a minimum of £10 and a maximum of £50 per offence and could lose Senior status.

14	<p>Only one team official may convey tactical instructions to the players during the match and must return to his position after doing so. Both team officials, who shall be identified to the match officials, and nominated on the official team sheet, must remain within the confines of the technical area, and they must behave in a responsible manner. Breaches of this rule by occupants of this area will be reported by the Referee, who shall have the power to impose sanctions as deemed fit.</p> <p>Note for Referees. Referees are instructed to report any Senior Club who fails to meet any of the standards included above and the League's continuing support of the Referee on the league's Senior Division could be in question if referees fail to make reports where necessary (in accordance with Law 5).</p>
